Growing up by giving back

Al-Anon has taught me how to grow up emotionally and spiritually. When I walked into my first Al-Anon meeting I was scared and lonely. I didn't want to be there. I considered leaving before the meeting even started. Then once the meeting started I began to feel something different. I began to feel a type of love and understanding than I had never experienced before. I was in a room full of people who did not know who I was; yet somehow they knew me. That group of individuals understood me and had compassion for me. They shared their experience, strength and hope with me. They told me to keep coming back and I did. They loved me until I learned to love myself.

It was suggested that I get a sponsor and begin working the Twelve Steps of Recovery. I listened and took action based on their suggestions. I began to get better. Soon I was encouraged to get involved in service work. Once again I was afraid. I thought I can't do this. I was afraid I wouldn't do it perfectly; and I haven't. My Higher Power had a lesson I was to learn through service work. I learned it is ok to make mistakes. There is a paragraph in the book "When I Got Busy, I Got Better" that says: "What I learned through Al-Anon service is that others want to see me succeed. Certainly my Higher Power is always with me and is always willing to encourage my success. My group, too, supports my efforts. I've also learned that the fate of my group doesn't rest in my hands, but rather in the hands of a Higher Power, who is not me. Help is always available." I know that throughout my journey in Al-Anon I have been guided by my Higher Power and through the love and experience of those who came before me and walk beside me. It is through service that I have been able to grow up and give back. It is when I get out of self and into others that I am able to feel like a person of value and worth. It is when I give of myself that I am able to receive from others. Today I am not afraid to give of myself, because today I am surrounded by a warm blanket of love by being a part of and participating in the world wide fellowship of Al-Anon Family Groups. Thank you for walking beside me, encouraging me, and giving me the opportunity to be of service to each of you and to Georgia Al-Anon. I too want to encourage you and see you succeed. Let's walk together to grow Georgia Al-Anon and Alateen by reaching out and carrying the message of hope.

For instance, do you know where to find the difference between a closed and an open meeting in the Service Manual? Do you know what the three obstacles to the success of Al-Anon are? Do you have any idea what is the purpose of our Charter? What Concept contains Bill W.'s essay on leadership that was written in 1959?

What if your group is considering asking a helping professional come speak to your group? What do we call a member that cannot attend meeting due to distance or disability? Write them down, talk with friends about their questions, ask your groups what they want to know- bring them with you and by all means bring your Service Manual; it will become your best friend.

AAPP Report

Greetings Friends!

I am thrilled to announce that our Area has many newly certified AMIAS. I am so excited to have new and enthusiastic volunteers to sponsor our Alateens. I want to extend a big thank you to all that spend your time and energy to continue Alateen in Georgia.

As many of you know, Georgia extended mandatory reporting laws to apply to all volunteers, including AMIAS. A few of us have been serving on a task force to determine how this change in the law impacts our fellowship. During this calendar year, we have enacted a temporary fix. Current AMIAS and perspective AMIAS have signed a paper acknowledging their role as a mandatory reporter. The notice also gives the AMIAS guidance as to how to proceed if they suspect abuse. Our task force is very close to resolving this issue. We hope to have information for AWSC and January Assembly. We want to be sure that our AMIAS feel supported by the fellowship and are aware of what is expected of them under the law.

WSO advised Alateen meetings in a state with mandatory reporting laws to include a disclosure statement at the beginning of each meeting. All Alateen groups have been provided such a disclosure statement. The use of this statement should already be in place and will be applicable to all Alateen groups operating in the state of Georgia. We want Alateens to be fully aware of our responsibility to their safety.

I look forward to seeing you all at the next Assembly.

Literature: it's all about the numbers!

- 1,596 The number of copies sold of the e-book version of *Having Had a Spiritual Awakening* since March! It costs \$9.99 and is available through e-book retailers.
- 990 the number of sharings WSO has received on the topic of intimacy in alcoholic relationships. There is no deadline for submissions. It takes about 2,500 sharings to make a book.
- +20,000 The number of copies *Reaching for Personal Freedom* has sold in English since it's publication in July. +1,100 have sold in Spanish and +900 have sold in French.
 - the number of sharings WSO has received on the topic of parents and grandparents dealing with alcoholic children/grandchildren. A sharing guideline is available on the members' website.
- 121 The number of copies of Al-Anon's first audio book *How Al-Anon Works For Friends and Families* sold in the first 10 days it was available. It is available through various electronic vendors.

You will notice a change in focus in the Literature Room when you come to January Assembly. It is in my job description to become familiar with every single piece of Conference Approved Literature we have. Yet there are pieces I have never even seen! Instead of being focused mostly on sales, we will focus on making every single piece of CAL available for you to check out. We will still sell literature, of course, but we will not stock a large number of each piece of CAL. If your group will need to purchase a large number of books, pamphlets, etc., I encourage you to place an order through the Central Office, MAIS, or directly from WSO.

If your group does place a pre-order to be picked up at Assembly, it will not be in the Literature Room. This will cut down on any confusion. Area Web Master's Report

Anonymity - A Spiritual Principle

Tradition 12. Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles above personalities.

It may seem strange that the principle of anonymity is called a spiritual principle. But the concept is that we are a fellowship of equals. There are no "rock stars" in Al-Anon. There is no "spokesperson" for Al-Anon. We're all struggling against the effects of alcoholism in our lives.

So how does that play out for the Webmaster? I have the responsibility of looking out for what's best for Al-Anon as a whole as to what gets posted on the GA Area web site (www.ga-al-anon.org). So I have to make sure anything posted maintains the anonymity of any Al-Anon or AA member. Two criteria I have to watch for 1) is any company name mentioned (like in an e-mail address) and point out that could imply endorsement. And 2) I have to ensure that first and last name is not used in the e-mail address.

We can be as anonymous as we wish or not anonymous WITHIN the fellowship. So we can use our last names in meetings (as long as they are not being taped). We can even put our full names on fliers, as long as they are only shared within meetings.

But the website is considered "public media." This will change when I get the "Members Only" section of the web site operational. But for now I have to send back any flier that has personally identifiable info on it.

How does this play out for your Internet use? If you are a trusted servant and send e-mails in that official capacity, it is suggested you use an anonymous e-mail address for that service. Any of the web-based e-mail services will set up a name as long as it isn't taken (e.g. I already have patrickb.afg taken at Gmail.) And we have many e-mail addresses that we can setup for an event at the "event@ga-al-anon.org" e-mail address.

Also, on social media such as Facebook, Instagram, Pinerest, and Twitter I can't mention that I am a member of Al-Anon. I can "Like" different recovery related pages because anybody in the public can like something without saying that they are members. But I can't start a public group for members of my Al-Anon friends.

So, the bottom line is, within the fellowship I can be as anonymous as I want. But on the web, I have to maintain my anonymity and that of others that I know are in the program.







A "closed" meeting is for anyone who is troubled by someone else's drinking.

An "**open**" meeting also welcomes guests, students, and interested professionals who want to learn by observing an Al-Anon meeting. Observers attending open Al-Anon meetings are requested to abide by the principles that guide participation in all Al-Anon Family Group meetings, most especially the principles of confidentiality and anonymity that protect its members.
